- Matches are best of 3 sets, the first 2 with a tie break when games are 6-6. If 1 set all, the third set will be a tie break.
- Spin for who gets choice of serving first and choice of ends as normal
- Please start each game with each player/pair starting with the score you are given by the organiser.
- No deuces - no need for a 2 point gap to win a game - at 40-40 next point wins.
- Occasionally one pair will start each set with a 1 game head start if the points handicap is slightly favouring one pair over the other.
- Please start each tie break using the handicap and target that you are given by the organiser.
- In any tie break, the first to the target wins, no need for a 2 point gap. If the handicap is an odd number, the first server serves 2 points (starting on the left court), otherwise they serve 1 point from the right and then all subsequent servers 2 points as normal.
- The player/pair serving first in each game has to call the score after every point.
- Change ends after 1,3,5,7 games etc, just like a normal match.
- The server should serve the first point of each game on the side shown next to "First Serve" on the draw sheet.
- For the purposes of the standings in the round robin, the third set will count as 1 set won and 1 game won.
